
PROVISIONAL SELECT LIST

1. In Pursuance to the Notification dated: 24.09.2016 cited at reference-1, recruitment process to fill up 18 posts of Sub-Inspector (KSISF) including in-service was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2011, Provisional Select List cited at reference-2 was published on 10.05.2017.
2. Two candidates who were selected for the post of Sub-Inspector (KSISF) Sri. Sharavan S Dasaraddi, bearing Roll No:3001511 and Sri. Doddabasappa H, bearing Roll No:3001234, vide affidavit cited at reference (3) have expressed their unwillingness to join the post. Accordingly, considering the request of the above two candidates their candidature was cancelled vide order No.50/Rect-2/2016-17, dated:19.08.2017.
3. Whereas, due to cancelling the candidature of two candidates namely Sri. Sharavan S Dasaraddi, and Sri. Doddabasappa H, Two posts in Sub-Inspector (KSISF) has remained unfilled. In order to fill up the two posts this Provisional Select List is being published with the following conditions.
 - a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
 - b) The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post which will be dependent on the aforesaid conditions.

c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
